

4. The **Omnibus Sworn Statement<sup>2</sup>** (for ABC's above Php 50k) (GPPB-prescribed forms), **Income/ Business Tax Return<sup>3</sup>** (for ABC's above Php 500k) will also be required to be submitted.
5. Quotations must be delivered to the address below on or before November 25, 2024, at 5 P.M.
6. The NTA reserves the right to accept or reject any quotation prior to contract award, without thereby incurring any liability to the affected interested parties.
